- No building visit was allowed in the constituency so that campaign workers could only distribute leaflets
- Candidate #3 (Mr. Lai, DP) set up a speaker at the intersecting point of the two roads, playing a tape which featured his accomplishments. Later, a policeman arrived and requested the DP campaign workers to remove it, due to some complaints by the residents.
- Candidate #2 (Mr. Yim, DAB) was in the constituency, but kept on communicating on mobile phone
- I had a conversation with a campaign worker for candidate #3. She was a woman who looked as in her 50s. She kept on praising candidate #3 for his hardworking style but avoided talking about his accomplishments
- There was a banner for candidate #2, near one of the pedestrian traffic light, suggesting that it was his achievement, to fight for the extension by 3 seconds, of the duration which the green pedestrian light blinks. (我爭取 此緣公仔亮多三秒)
- Finally, I found candidate #1 (Mr. Wong, independent), and had a brief conversation with him. He mainly talked about his difficulties, both in terms of resources and manpower. He also complained that the party candidates (candidate #4 is from ADPL) often violate the election regulations, like using bigger banners and putting them on some prohibited area. He claimed that the election officer tended not to do anything to solve the problem.
- I didn't see candidate #4 and her campaign workers during my observation

Conclusions drawn from your observation

- It seems that there is no risk to violate the election regulations
- Independent candidate has a greater difficulty to mobilize campaign workers, also the resources would be less
- Many tiny 'accomplishments' were emphasized

New questions generated from your observations or findings

- Despite the difficulties faced, why independent candidates are willing to take part in the election?
- What is the role of a district councilor? Is it his main duty to fight for 'community things' like the extension of blinking the green light?
- Is it the case that party candidates need not to pay too much effort to fight for voters, as they have the support of the parties?
